Distinguished Career Achievement Award



Larry E. Davis, PhD University of Pittsburgh

Larry E. Davis has spent his life and career dedicated to issues of race, civil rights, and social justice. He earned a bachelor's degree in psychology from Michigan State University and a Masters in social work, and a Masters in psychology from the University of Michigan. He then decided to work in the trenches, joining VISTA and spending three years in one of New York City's poorest neighborhoods.

He returned to academia and became the first African-American to earn a Ph.D. from the dual-degree program in social work and psychology at the University of Michigan. He pursued both degrees because he believed that the methodology of

psychology combined with the tools of social work would enable him to bridge the gap between analysis and application.

Over the years, Dr. Davis' work has been funded by the National Institutes of Health, the National Institute of Mental Health and the National Science Foundation. He was the first African-American in any discipline to be awarded tenure at Washington University in St. Louis, where he was a Professor of Social Work and Psychology and the holder of the E. Desmond Lee Chair in Ethnic and Racial Diversity.

In 2001, Dr. Davis was recruited to the University of Pittsburgh, where he serves as Dean of the School of Social Work and holds the Donald M. Henderson Chair. At Pitt, he also became the founding Director of the Center for Race and Social Problems, which conducts applied social science research on race, ethnicity, and color, the first such center to be created in any American school of Social Work.
